

Working Group on the Protocol of San Salvador



The Working Group on the Protocol of San Salvador (Working Group) is the monitoring body of the <u>Protocol of San Salvador</u> and functions in the framework of the <u>Inter-American Council for Integral Development</u>. The Protocol of San Salvador is an additional and optional protocol to the <u>American Convention on Human Rights</u> that enshrines social, economic, and cultural rights. Pursuant to resolution <u>AG/RES. 2262 (XXXVII-O/07)</u>, adopted on June 5, 2007, the Working Group is tasked with monitoring the implementation of the Protocol of San Salvador, and examining the periodic reports that States parties are required to submit.

The Working Group is composed of three government experts elected by the States parties during the <u>General Assembly</u> of the <u>Organization of American States</u> (OAS), taking account of

equitable geographic distribution, one independent expert, and one member of the <u>Inter-American Commission on Human Rights</u>, in addition to three alternate members (one from each category). <u>Civil society</u> organizations may participate in joint meetings with the Working Group and in consultations.

States Parties to the Working Group on the Protocol of San Salvador:

Nineteen of the <u>35 OAS Member States</u> have signed the Protocol and 16 have ratified it. Those 16 are: Argentina, Bolivia, Brazil, Colombia, Costa Rica, Ecuador, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Paraguay, Peru, Suriname, and Uruguay.

The Working Group's Activities:

- Prepare <u>Progress Indicators for Measuring Rights Under the Protocol of San Salvador</u> and make recommendations to States. These are published on the Working Group's <u>website</u>.
- Conduct <u>sessions</u> to analyze the <u>national reports</u> related to the Protocol of San Salvador
- Publish Reports of Activities
- Engage with <u>civil society</u> on various issues related to its mandate
- Prepare and compile other <u>resources and tools</u> useful for advancing social, economic, and cultural rights
